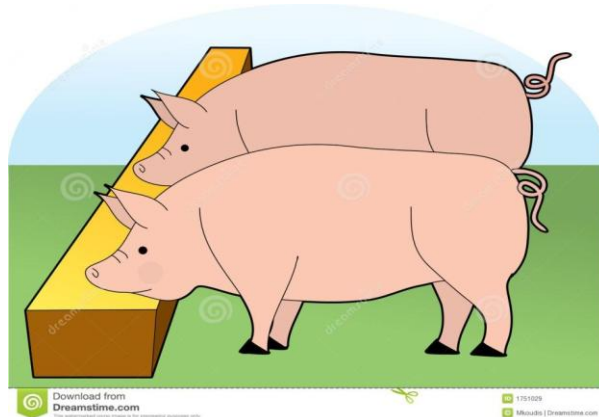

DISPOSAL OF CAFETERIA SWILL SPECIFICATIONS

1. Bidder will provide two clean and empty 33-gallon containers (no larger) with fitted lids.
2. Bidder will supply trash bags to fit a 33-gallon container and secure them inside the container.
3. Bidder will deliver containers as specified in lines 1 & 2 to the school each day no later than 2:00 pm. At the same time Bidder will pick up filled containers to haul away and dispose. It is recommended that Bidder have at a minimum four 33-gallon containers available for this process.
4. Bidder will be responsible for replacing any containers that incur damage such as holes or cracks due to daily use.
5. Bidder will be responsible for keeping the pick-up area clean of any spill or waste.
6. Bidder will operate and haul away and dispose of all swill/garbage in accordance with all applicable State and Federal laws, rules, and regulations.
7. Service period is anticipated to start on **August 5th, 2024 through and including May 30, 2025**. Holidays or no student days will have no pick-up. Dates are subject change based on school schedule.

9. Email bids must be received by Lisa.Omalsa@kualapuu.k12.hi.us by the deadline date/time. (Friday, July 19, 12 noon.)
10. A minimum of ½ payment of the total bid is required prior to each semester, by Wednesday, July 31, 2024, and Tuesday, December 31, 2024. In the event of failure to pay, the school reserves the right to award the collection to the next winning bidder.
11. The Kualapuu School cafeteria will not guarantee the volume of swill available each day.
12. In the event there are two tied winning bids, the award will go to the bidder who submitted their bid via email first. The date and time sent/received by the school will be the official determination.
13. Non-compliance will be grounds for termination by either party.
14. Bidder must provide 30-days written notice if they are not able to fulfill their obligation. Bid payment will not be refunded. Upon notification from the bidder the school will:
 - a. Offer the collection to the other bidder in the tie if such was the case; or
 - b. Offer the collection to the second highest bidder; or
 - c. Re-bid.
